



REQUIREMENTS FOR A TRANSIENT VENDORS LICENSE MUNICIPAL CODE CHAPTER 2 SECTION 9

It shall be unlawful for any peddler, canvasser or solicitor, or transient merchant to ply his trade within the corporate limits without first obtaining a permit.

No permit shall be used at any time by any person other than the one to whom the permit it is issued.

Exemptions to permit: Yard sale and used merchandise; Farm raised products direct from the farm it was raised; Wholesalers to Dealers; newspaper route carriers; bona fide charitable, religious, patriotic or philanthropic organizations.

Must be located on private property. Not allowed on public right of way or city owned property.

- Complete Application with \$5.00 application fee
- Provide copy of Driver's License
- Allow 72 hours for Chief of Police to investigate applicant
- Provide a \$1,000.00 surety bond running to the Town of Erwin
- Pay \$50.00 Transient Vendor's License Fee
- Good for 14 days from date of issue
- Permit may be revoked or suspended in accordance with 9-211 of the Municipal Code
- Recommended sale hours are dawn to dusk
